# § 1 Purpose of the Training

## § 5 Trainee Obligations

The trainee agrees to: - Diligently carry out assigned tasks. - Adhere to scheduled working hours and internal regulations. - Comply with safety and confidentiality rules.

### § 6 Certificate of Completion

Upon completion of the training, the employer shall issue a certificate stating the place, dates, and duration of the placement. This certificate must be submitted to the school within two weeks and shall not contain negative remarks affecting the trainee's future career.

#### § 7 Termination of Contract

Early termination is permitted: - By mutual agreement, or - By one party, for reasons that make continued training unreasonable or unacceptable.
